

Do You Have A "**CALLING**"?

How many of you out there have ever called the C.A. Hotline? If you have, you know how good it feels to connect with someone in recovery who understands how you feel. We in the Greater Saint Louis District are very proud of the fact that our phones are answered/monitored 24/7 strictly by sober recovering addicts.

Do you have four months or more sobriety, a touch tone telephone, and a willingness to help your fellowship? Why not sign up for a Hotline volunteer slot? What this means is that you commit to a four hour time period once a week to answer the phones for Saint Louis C.A. This is accomplished through a call-forwarding feature that allows you to do your service work within the comfort of your own home, car, at the park—wherever you happen to be that you can answer the phone and give fellowship information to callers interested in learning about Cocaine Anonymous.

We are particularly in need of volunteers who can take a mid-week; mid-day shift. As you can imagine, most people are working during that time frame (surprise, surprise—addicts get sober and get jobs!!!). Currently open are the following time slots:

7 AM – 11 AM	Wednesday
11 AM – 3 PM	Tuesday/Wednesday/Friday/Saturday
3 PM – 7 PM	Monday/Tuesday/Wednesday/Thursday
7 PM – 11 PM	Monday/Wednesday

If you see a day and time listed above that you would be willing to commit to covering each week, please contact Laura N. at 636/577-4760. All that is required is a short orientation which can be done by phone. You will then be ready to step to the plate and serve C.A. in one of the most vital opportunities for service available.


