Step Two: Came to believe in a Power greater than ourselves that could restore us to sanity.

Traditionally, when some of us talk about "coming to believe", we refer to it as a *process*. I can't say that my process was much different than others', but I can say that it was wholly my own.

My childhood was not filled with church related activities or Bible School. My family, which consisted of my mother, my brother, and I, lived a nonreligious life, secular to the core. The only time God was considered was in our ritual bedtime prayer, "Now I lay me down to sleep..." The prayer became more abstract and iconic as years passed.

The next time that God entered the picture was twenty years later, in my crack smoking days. "Please God, if you get me out of here I will never smoke crack again," I prayed one New Year's Eve in Kansas City, Kansas as guns were being fired into the air around me. My experience now is that God can do all things, but I guess I needed some more time out there before I was ready to let Him.

I have known all along that the fundamental idea of God was deep down inside of me. It just amazes me how I could have lived so long ignoring Him! I knew the difference between right and wrong, but for me it took the miracle of crack addiction and recovery to accept it.

At first, I was only able to display a "willingness". That was all it took for me to commence my relationship with Him. Secondly, I had to understand that my conception of a Higher Power didn't have to be like anyone else's. Finally, I had to come to believe that my Higher Power could *restore me to sanity*.

I presumed that the part about sanity was going to be difficult. My body was in shambles; my mental health was a mess... but, I trusted that once I straightened out spiritually, I would straighten out physically and mentally as well.

God has worked miracles in my life. I have been able to graduate from college and become a productive member of society. I have gotten involved in lasting relationships with my sponsor and many members of the fellowship. While continuing with the steps, My Higher Power, the Fellowship, and I have created a way of life that works. It really does!

Traditions Corner:

#### Traditon Four

Each group should be autonomous except in matters affecting other groups or C.A. as a whole.

The first thing I needed to be clear on is what constitutes a 'group'? Just like a member is a member when they say they are, basically so is a group, although there are some conditions that need to be met. The following is an excerpt from the 2008 WSM:

#### DEFINITION OF A COCAINE ANONYMOUS "GROUP"

A meeting is when two or more people gather together to share their experience, strength and hope with each other. A meeting may call itself a C.A. Group when:

1. The only requirement for membership is a desire to stop using cocaine and all other mind altering substances.

2. It is fully self-supporting.

 Its primary purpose is to help addicts recover through the Twelve Steps of C.A.
It has no outside affiliations.

- 5. It has no opinion on outside issues.
- 6. Its public relations policy is based on attraction rather than promotion.

Traditions, con't.....

With that said, there are just about as many type of groups as there are individuals! I have found just like members have their own nuances and personalities, so do groups. That is part of the beauty of Cocaine Anonymous: we are not just cookie cutter groups and if you come across a group that doesn't necessarily appeal to you, you don't have to discount the whole fellowship, but you are free to seek out another group that may be more to your liking! Another option is, especially if there is a need for it and it's not just spouting from a resentment, to grab another addict and start a new group! There are plenty of parts of our area that still do not have CA and there is plenty of opportunity to reach the still suffering addict! But that is leaning toward the next tradition; let me stick with tradition four. The fourth step asks us to take a searching and fearless moral inventory of ourselves and this tradition asks the group to inventory its own actions, to see where decisions made and action taken may be affecting CA as a whole. That does require a willingness of the group to look at itself but not to just be thinking of themselves: we need to look outside and see how our actions are affecting others. We also have the option of turning to others for guidance. One of the purposes of the District is to serve the groups and the members, and you are free to bring group concerns to the District. Another option is the Area, and also we have the benefit of the knowledge of World Service delegates, who also have access to delegates in other areas, who have guite often had experience with the same issues in their areas. Just like we as individuals can benefit from other individual's experience strength and hope, we can benefit from other groups experience strength and hope. And also available, is our Regional Trustee. They meet with the other trustees regularly via conference calls and regularly scheduled meetings and have access to wealth of information. If your group is making a decision which you think may affect CA as a whole, and you really like it, consider the fact that maybe it is something that could be beneficial to the entire Fellowship. Again, that is where your delegate can assist you. The World Service Conference is taking place right before Labor Day, and if you have an idea that you would like to see presented to the entire Fellowship, contact your delegate on how to submit a Referral to Conference. If on the other hand you change your mind and think well maybe it's not just a great idea, then it might be a great time to institute Rule #62:

"Don't take yourself too damn seriously"

# Step 3

## Made a decision to turn our will and our lives over to the care of God as we understood Him.

Decisions, Decisions, Decisions....

What should I wear today...that green dress or the red top with the white pants?

Do I want to drink and get high today...or not?Do I want to experience Peace of Mind or do I want to experience Conflict? Lately, I have been asking myself the last question. And although it is a question, it is also a decision that I have to make. My experiences with making decisions were not easy for me. Unfortunately, I had formed a habit of making my life really difficult. And when I couldn't decide what to do, I could and would find a way to escape – thus the easier, softer way. "...always in collision with something or somebody"– that's what the Big Book says and usually the "somebody" was me attached with a good motive or bright idea, and it didn't matter if I was being selfish or not. I was <u>always</u> the victim and it was <u>always</u> somebody else's fault. Well, that's one result of me not making decisions and allowing other people to make them for me. And it's also called giving people control over me and when things didn't work out like I thought they should or hoped they would, it was their fault. And me being the addict that I am, of course I would let them know that it was their fault, especially when I started to "behave differently". Sometimes, I wondered why no one wanted to be bothered with me and why sometimes I didn't know that not being accountable for me was being very selfish.

"How dare you treat me like a child?", "How dare you try to leave me?", "It ain't over until I say it's over!!", "I'm grown and you don't tell me what to do!!!!", "Don't you know who I am?" Who do you think you are? Of course this is not what I really said; this is the mild and clean version. I would ask these questions, make some of the craziest statements and act a complete nut when I was in some type of denial or emotional down-spiral. And that usually happened when I was on some different-other-type-of-stuff; when I thought that no one loved me or wanted me...even God. As a child, I had the privilege to meet God through my grandmother, and I learned to pray, read the bible and go to church; and then faith came and I believed in God. But what's sad is I didn't know that as an adult, I could use that same child-like faith to believe that God loved me and I was still the apple of His eye.

But for the Grace and tender-loving Mercy of God Almighty and the Fellowship of Cocaine Anonymous, I've come to understand that making a decision doesn't have to be hard. I also found out that turning my life and will over to God's care didn't have to be hard either. I was having such difficulty in making decisions because I didn't want to be responsible for the outcome. I had forgotten all that I had been taught that the outcome was not up to me because that's God's job; and He don't need my help. You've heard it said time and time again, "...plan, but don't plan the outcome." I was also having difficulty in understanding God and that's because I wasn't standing under God and that's because I was trying to be God. Ok, you can say it and today, I agree – WE THINK NOT!! I realize today that I have to stand under God, first, in order to understand what God is saying to me, through me and for me. I needed to know that God's will is God's word, and God's word is God's way. God is in total control of everything - not me. That's the jest of what I truly need to understand. In other words, when I step from the umbrella of God's care, which is His love, I put myself in a position to be hurt and attacked or vice versa. I also give the adversary the opportunity to mess with me and my mind and I give my infamous "committee" permission to mess with me too. When I step from the umbrella of God's care, I am then operating out of fear and running on self. When in actuality, all I need to do and should do is pause, ask for quiet, and in the stillness simply say:

"God, grant me the serenity to accept the things I cannot change, courage to change the things I can, and the wisdom to know the difference. Living one day at a time, enjoying one moment at a time, accepting hardships as the pathway to peace; taking as He did this sinful world as it is and not as I would have it; trusting that He will make all things right, if I surrender to His will; that I may be reasonably happy in this life and supremely happy with Him forever in the next. Amen." (Anonymous) And when I do that, I am operating in faith, relying on God and not running at all. And to answer that last question, just for today, I have decided to experience Peace of Mind. I hope and pray that you will decide to do the same – "Thy will, not mine, be done." (pg 41)
