My Delegate Journey By Leslie R. Kansas City, MO

I arrived at the rooms of Cocaine Anonymous(C.A.) with six months of sobriety in 2003, and at once, I knew I was finally at home. I found a place where I could be fully me; an addict and an alcoholic. I had attended meetings of A.A. and N.A., but I was never completely comfortable in either fellowship. A.A. didn't want to hear about my drug addiction and N.A. didn't want to hear about my alcoholism.

In my first C.A. meeting they read "Who Is a Cocaine Addict" and "Who is a C.A. Member" and I heard my story in them. I was filled with hope and the desire to be a part of CA and found my first C.A. homegroup. I got a new C.A. sponsor, I worked the steps, I changed, I grew, and I wanted more. In sponsoring others, I experienced the power in giving away what was so freely given to me. I attended workshops and 12 Step and 12 Tradition studies which led to a deeper understanding of how our Fellowship continues to flourish and grow. I took on small service commitments like setting up the meeting space, making coffee, chairing meetings, and serving on event committees. In turn this led to serving at District and Area levels.

When one of our home group members became a delegate to the World Service Organization of Cocaine Anonymous, I was inspired by his dedication. I didn't know anything about service at that level and the Twelve Concepts were a bit confusing, but the example of his service and his love for C.A. stayed with me as I grew in my recovery.

In 2022 I was elected as a Delegate for the Greater Missouri Area. I had served as a Delegate for C.A. Thailand in 2019, however my service was cut short due to the Covid 19 pandemic. I was locked out of Thailand while travelling in the U.S. in March of 2020, and not knowing when I would be allowed to return to Thailand, I took a job in Kansas City and three and a half years later I am still living and working in Kansas City.

Attending the World Service Conference in Atlanta 2023, I was shown love, admiration, and inspiration by fellow members who give so freely of their time to serve the Fellowship they love. I watched the 12 Concepts come

alive on the conference floor. The right of minority opinion to be heard, which is the foundation of the 5th Concept. The right of participation which gives us a voice and a vote which is the basis of the 4th Concept. I learned about the important roles and responsibilities of the World Service Board of Trustees and the World Service Office Board in serving our fellowship and ensuring C.A.'s growth. I remain in awe of how our Fellowship has trusted servants, but no governance. That our ultimate authority is a loving God as He may express Himself in our group conscious as set forth in Tradition 2 along with Concept 1 which states the final responsibility and the ultimate authority for C.A. World Services should always reside in the collective conscious of the of our whole Fellowship.

Each Delegate serves on one of the 10 World Service Conference Committees. I chose the Public Information Committee (PI) as I felt it would best serve the Greater Missouri Area which I represent. The PI Committee is tasked with getting the word out to suffering addicts and to the general public that C.A. is here and that we offer a solution to both alcoholism and drug addiction. C.A is not well known in the Midwest and serving on PI Committee, we work to remedy this situation.

Serving as a Delegate has been both an enormous gift and a huge honor. It has enhanced my recovery and my life in immeasurable ways. That an addict like me would be considered a trusted servant to the World Service Organization of C.A. was something I could not even have fathomed in early recovery. I am forever grateful to those members who served before me, alongside of me, and those who will come after me. I am forever grateful to C.A. for giving this addict and alcoholic a home. When I got sober it was for one reason and one reason only... to make the pain stop. I had no other goals. Well, the pain did stop and I was healed long ago, but what I got was so much more than that; my life is filled with meaning, purpose, and love. I have truly been given a life beyond my wildest dreams by serving the Fellowship I love, Cocaine Anonymous.
